We are proud to present the eighteenth annual Arts at the Gardens, a juried fine art show to be held on the grounds of the historic Sonnenberg Mansion in Canandaigua, New York. The two-day event is open to applicants throughout the U.S. and Canada.

The setting for the show is the gardens of this splendid estate, which the Smithsonian Institution considers "one of the greatest late Victorian gardens created in the United States...that has survived completely intact." And, Canandaigua is located just 7 miles south of the New York Thruway, in the beautiful Finger Lakes Region, providing easy access to Sonnenberg from the metropolitan areas of Buffalo, Rochester and Syracuse.

The event is promoted extensively in all major media to ensure the greatest number of visitors. A \$7 gate fee is charged to visitors. This show is quickly becoming one of the premier art events in the Northeast.

SELECT CALL FOR ARTISTS APPLICATION THE SCULPTURE GARDEN

The Sculpture Garden returns! Initiated in 2015, the Sculpture Garden at Arts at the Gardens, integrates large scale sculptural installations into the environment and grounds of Sonnenberg Gardens and Mansion State Historic Park. The setting is exceptional for large installations. The sculptures are placed throughout the property, on grass or gravel, to further transform the grounds into an artistic oasis.

The sculptural installations invite viewers to become involved in the dynamic relationship between sculptural pieces and their neighboring environment. Space, gravity, discovery- are all reinforced by the natural elements, eliciting thoughts and feelings of euphoria, awe, bewilderment and peace.

Program Specifics/Sculpture Placement:

Sculptures will be placed on the grounds of Sonnenberg Gardens and Mansion State Historic Park during the duration of Arts at the Gardens. Each artist will receive a 10x10' grass or gravel space, decided, upon acceptance, by the curator and director of the program.

An anonymous panel of jurors will select participating Artists. Up to 10 artists are selected, based on selection criteria. Each participating artist will exhibit one work of art. Of the 10 participating artists, one sculpture will be selected as the Sculpture Gardens and Rochester Contemporary Art Center's, "**Merit Award Recipient.**"

Sculpture Scavenger Hunt

The Sculpture Garden Scavenger Hunt is a bit of fun that the whole family can enjoy! Guests are invited to follow the map to try and locate each sculpture on the property, including those that are part of Sonnenberg Gardens and Mansion State Historic Park's permanent collection. Those wishing to complete the scavenger hunt and submit contact data, will be entered into a raffle.

The Scavenger Hunt also acts as a sculpture map, and detailed information on the works is also provided including price, artist information and artist statement.

AWARDS AND RIBBONS

One cash award (\$150.00), and RoCo Prize will be presented Sat. evening at the artist reception at 6pm and posted Sunday. 2018 winners are offered automatic acceptance into the 2019 Sculpture Garden; jurying and the \$25 processing fee are waived.

AWARD ELIGIBILITY

Awards are given for **original works only** and at the discretion of the judges.

ENTRY DEADLINE

Applications must be postmarked by May 1, 2018. Entrants will then be juried, with responses mailed and/or e-mailed before May 15, 2018.

Completed application acknowledges artists recognition of Sales agreement:

Sales Commission= 30%to Arts at the Gardens, 70% to the Artist.

SHOW RULES

Show Rules. All displays will be inspected at intervals throughout the show.

No Commercial Products. Only original artist-created work may be displayed. All items must be hand-crafted by the exhibitor.

Commitment to Show. A signed application is a commitment to show. No refunds for cancellation will be made less than 90 days prior to the show.

Waitlist Procedures. A Waiting List of qualified candidates will be maintained and artists will be notified should a space become available.

Agents. Dealers or agents may not stand in proxy for artists they represent.

Sales Tax. All exhibitors must have a current New York State sales tax number.

Interpretation of the Rules. Arts At The Gardens reserves the right to make final interpretations of the rules. The jury consists of Regional fine art professionals, highly experienced in each of the categories. Jurying is anonymous. Artist selection is made solely on the basis of work as seen in the submissions. Work is scored on a numerical basis; artists with the highest scores in each category will be accepted. Therefore, image quality is of utmost importance. Decisions of the jurors are final. Calls questioning or disputing the jurors' decision will not be accepted. Prior participation in *Arts at the Gardens* does not guarantee future acceptance.

DISPLAY REQUIREMENTS

Spaces. Spaces are approximately 10-feet wide by 10-feet deep.

DISPLAY. One large piece, must be juried and accepted.

SUBMISSION INSTRUCTIONS

Read and follow the instructions carefully. Incomplete or unsigned applications will NOT be accepted.
