We are proud to present the nineteenth annual Arts at the Gardens, a juried fine art show to be held on the grounds of the historic Sonnenberg Mansion in Canandaigua, New York. The two-day event is open to applicants throughout the U.S. and Canada.

The setting for the show is the gardens of this splendid estate, which the Smithsonian Institution considers "one of the greatest late Victorian gardens created in the United States. . . that has survived completely intact." And, Canandaigua is located just 7 miles south of the New York Thruway, in the beautiful Finger Lakes Region, providing easy access to Sonnenberg from the metropolitan areas of Buffalo, Rochester and Syracuse.

The event is promoted extensively in all major media to ensure the greatest number of visitors. A \$7 gate fee is charged to visitors. This show is quickly becoming one of the premier art events in the Northeast.

We look forward to your participation in 2019.

JURIED CASH AWARDS

AWARDS AND RIBBONS

Ten cash awards will be presented Sat. (10 additional acknowledgement awards, waiving processing fee for 2020 will be awarded Sunday). 2019 winners are offered automatic acceptance into the 2020 Arts at the Gardens show; jurying and the \$25 processing fee are waived.

AWARD ELIGIBILITY

Exhibitors must be present with their work when it is judged. Awards are given for **original works only** and at the discretion of the judges.

ENTRY DEADLINE

Applications postmarked by March 1st, 2019 will qualify for a \$275 booth fee. Applications postmarked after March 1st, 2019 will be subject to a \$325 booth fee. All applications must be postmarked by April 15, 2019. Entrants will then be juried, with responses mailed and/or e-mailed before April 30, 2019. If an artist is rejected, all fees—except the processing fee—will be refunded.

Only original artist-created work may be displayed; No manufactured, commercial or imported products will be allowed. Work must be tasteful and in keeping with a family-oriented atmosphere.

SHOW RULES

Show Rules. All displays will be inspected at intervals throughout the show to ensure that exhibitors comply with show rules. Two artists are allowed to share a booth if at least 10% of their exhibit consists of collaborative work made by both artists. It is the exclusive right and responsibility of the show committee to interpret show rules and to require an artist to remove any work not in compliance with these rules. Should violations be repeated, the artist will be asked to remove his or her exhibit(s) from the show and will forfeit eligibility for participation in future Arts At The Gardens.

No Commercial Products. Only original artist-created work may be displayed. All items must be hand-crafted by the exhibitor. No imports, kits, items made from kits or pre-manufactured items are allowed. No more than 20% of an artist's booth may contain reproductions.

Commitment to Show. A signed application is a commitment to show. No refunds for cancellation will be made less than 90 days prior to the show.

Waitlist Procedures. A Waiting List of qualified candidates will be maintained and artists will be notified should a space become available.

Agents. Dealers or agents may not stand in proxy for artists they represent.

Sales Tax. All exhibitors must have a current New York State sales tax number and must display their sales tax certificate during the show.

Interpretation of the Rules. Arts At The Gardens reserves the right to make final interpretations of the rules. The jury consists of Regional fine art professionals, highly experienced in each of the categories. Jurying is anonymous. Artist selection is made solely on the basis of work as seen in the submissions. Work is scored on a numerical basis; artists with the highest scores in each category will be accepted. Therefore, image quality is of utmost importance. Decisions of the jurors are final. Calls questioning or disputing the jurors' decision will not be accepted. Prior participation in *Arts at the Gardens* does not guarantee future acceptance.

No Pets are allowed on the show grounds. No bicycles allowed on Sonnenberg grounds. During restocking- all vehicles must be removed from show grounds by 9:15am and parked in designated areas.

DISPLAY REQUIREMENTS

Booth Spaces. Booth spaces are approximately 12-feet wide by 12-feet deep. Booth spaces are available to individual artists, team artists, and guilds. All exhibitors are expected to bring their own display units, materials, tables, chairs, tents, panels, covers, etc. **All tent tops and sides must be white.**

DISPLAY. A minimum of 12 pieces must be displayed per booth. A portfolio of matted or framed works may be kept in a viewing bin, but must remain within the confines of the booth(s). Card racks must be kept inside the booth.

- Artists may display work, including materials in the viewing bin, only in the categories in which their work has been juried and accepted. All work exhibited must be comparable to work submitted with the application.
- All work must be totally attributable to the displaying artist(s). Reproductions are not to exceed 20% of the exhibition.
- Electricity. Electricity is available for \$35. Generators are not allowed.

SUBMISSION INSTRUCTIONS

Read and follow the instructions carefully. Incomplete or unsigned applications will NOT be accepted.

Submit four (4) images: three (3) close-ups of your work, and one (1) of your booth as it will look during the show. An image of booth is mandatory.

- Images must be in jpg format (300 dpi preferred for each image). Professional Images Preferred.
- Write your name and telephone number on the compact disk, or Name in Subject Line

Images must be of good quality and be an accurate and current representation of the size, style and quality of ALL work to be exhibited. Applicants not conforming to this rule will be ineligible to show. Photographs of work will not be accepted.

If you select to have your CD returned- Disks of accepted exhibitors will be returned in the exhibitor kit upon registration at the show. Refunded fees will be returned to artists not selected.

To ensure that disks are returned in the event you are not selected, please include a return envelope with sufficient postage.

2018 Award Winners are automatically accepted into the 2019 show. However, you must fill out the application and enclose the \$275 / \$325 show fee. The \$25 processing fee is waived.
